## **THE 79th ANNUAL RETIRED OFFICERS' BANQUET**

### **“ Oh, What a Night it Was!”**



On Wednesday, September 20th, 2023 the 79th Annual Retired Officer's Banquet returned to the SPAA Range Pavilion and the place was packed. Members of the SPD Mounted Unit greeted the crowd of almost 400 as they lined up outside. Once inside, the retirees and their guests were amazed at the decorations. Floor to ceiling curtains and strings of lights "fancied up" the place. The 40 tables were covered in either blue or white tablecloths and the police themed centerpieces were courtesy of former PEO Marianna Matthews. The bar was open and hopping with four professional volunteer bartenders. New for this year, was a backdrop mural of the Seattle Waterfront. In front of that mural was a SPD Traffic Motorcycle. It was a great spot to get a few photos. Also new this year were banners depicting the academy classes from the 1930's all the way through the 1970's. Many thanks to the SPD Photo Unit who designed the banners. Classes from the 1980's and beyond were displayed on cardboard posters on tables throughout the room. Near the stage was another table-top banner honoring all of the SPD officers who were killed in the line of duty. Small blue votive lights gave a somber glow to the display. As the crowd enjoyed appetizers and drinks, an old film of the SPD Marching Drill Team was projected onto the wall behind the stage. The SPD Honor Guard presented the colors as Elaina Cote (daughter of retired SPD Joe & Debbie Cepeda) sang an amazing rendition of the National Anthem. Charlie Scoma, the SPD Chaplain, offered a prayer thanking everyone in the room for their many years of service. During the buffet dinner, former SPD and current SFD, Steve Olson, entertained the crowd with his guitar and amazing vocals. Following dinner, RSPOA President Jerry Taylor welcomed those gathered. Master of Ceremonies, Kevin O'Neill, welcomed all of the VIPs, including former King County Sheriff and candidate for Washington State Governor, Dave Reichert. Rich O'Neill urged everyone to make sure they join the RSPOA when they retire for many reasons, but especially because the RSPOA protects our pensions in Olympia! A list of the recent retirees, who were present, were read aloud and they came forward for a group picture and to be congratulated on their retirement. The lights were then lowered for a solemn presentation of the Last Ring. The names of those SPD officers who passed away since the last banquet were read aloud as their pictures were projected on the stage wall. SPD Piper Aaron Stoltz then played Amazing Grace as the crowd stood in silence. Several new things at this years banquet included awards for the "highest serial number in the room" and "farthest traveled" (details on page 3). Also new this year, was the showing of old photos. They were projected on the stage wall throughout the night. Then it was time to honor the 3 lowest serial numbers in the room. Marty Spotankse took the bronze medal, John L Sullivan won the silver and for the third year in a row, Phil Cruse took home the gold medal. Elaina Cote returned to the stage to sing, God Bless America, as all of the veterans in the room were asked to stand. As the official program festivities ended, Steve Olson continued to paly for those enjoying the bar and the chance to talk with old friends.

## President's Message

### RSPOA the Future

We have recently experienced the plague that severely impacted the organization. We were, for the most part, able to continue our meetings but, did cancel one Retired Officers' Banquet. The real impact has been more hidden. First was a caterer change at the Nile. We were suddenly presented with significant increases in food costs and room rental fees. As we attempted to negotiate a more reasonable fee structure, we were simply pushed out. That followed by our attempts to move our meetings to a new venue. First, we tried a restaurant in Montlake Terrace. Nice folks but, the venue just did not work. Then we moved to the Shoreline Elks. They were very helpful and attempted to meet our needs. Unfortunately, the Elks did not have a full-time kitchen staff and was attempting to provide services with volunteers. After a couple of months, it became apparent that the Elks would not work well for RSPOA.

In the meantime, RAP which was facing the same venue challenge, worked out an agreement with the Nile to provide the meeting room at a rate they could afford. RAP met the cost by raising the meeting dues from \$1 to \$6 and returned to the Nile. Since meals at RAP were ordered from a menu and paid directly, by the member, the situation permitted the Nile to rely solely on the room rental and direct meal sales off the menu. This \$20+ increase has not had any adverse impact on the attendance at the RAP meetings.

The RSPOA has been faced with a more difficult challenge. Our meetings are generally larger than RAP and do not lend themselves to individual orders from a menu. Hence, we use the buffet approach. We advise them of the anticipated attendance, and they provide the lunch. The main problem is that we often do not know how many will attend any given meeting. While attendance is normally in the 40 -50 range it is not uncommon for us to have sixty or more. For example, our November meeting speaker is Dave Reichert. In October he drew 500 people to a fund raiser in Bellevue. The room rental rates for the large meeting room at the Nile are well beyond our budget. Additionally, since we provide a buffet we have to provide a service number to the Nile and we have to pay for that number even if fewer show. Providing the number of anticipated attendees drives Nick crazy, but he generally does a magnificent job of selecting the number. We were able to strike an agreement with RAP whereby we share our monthly meeting with them. That kept our room charge at an acceptable level and lessened the burden for RAP. So our meetings have moved from the second Wednesday of each month to the second Thursday of each month and have relocated to the Nile.

I started out discussing the impact of the plague, so I guess I should explain how that impacts our meetings and lunches. Actually, it impacts just about everything when trying to run an organization. Inflation hit. The price of everything went up. The buffet cost increased. We have only been collecting \$10 a head for lunches. That does not cover the cost. Since we first moved to


### Robert "Bob" M. Avery #2121,




## WAR STORIES

In April 1998, at about 10:15 pm, my partner, John Nordlund and I were called to a homicide scene outside 515 22nd Avenue. The victim had been shot several times. Fire Department medics had transported him from the scene to Harborview Medical Center, where he died soon after arrival. We eventually determined that the victim was from Tacoma and went by the name, Buddy. His grandparents had raised him. We were still working on the murder three days later, when I called his grandparents' home.

An elderly-sounding woman answered the phone.

"I'm Detective Steiger from the Seattle Police Department," I said. "I'm investigating Buddy's murder."

I heard a scream on the phone.

"Buddy's dead?" she yelled.

I had presumed (apparently in error) that she had been notified of Buddy's death by the Medical Examiner's Office. After a very uncomfortable moment, where I apologized and gave her my condolences, she calmed down. She told me what she knew about Buddy's last night alive. Based on her information, we were able to track down one of Buddy's friends. He had driven Buddy to Seattle that night. We picked that friend up and brought him in for questioning.

Only a short time into my interview, I was convinced this guy was the killer. We talked about his life. He'd been a gangbanger since he was thirteen.

"I know what you're going through," I told him softly. "You're too old for this shit." (He was 26.)

"Your nerves are constantly on edge," I said. "You're looking over your shoulder all the time, either for the police or for someone trying to kill you. Aren't you tired of it? It's time to stop this life and get on with it."

He stared at me, not saying anything at first. Finally, he said in a near whisper, "Man, it's like you can read my mind."

It was true. I'd spoken to scores of people just like him before.

Eventually, he confessed to killing Buddy—another stupid murder for no reason.



# From the Police Museum

When Seattle hosted the Alaska-Yukon-Pacific Exposition (AYP) in 1909, it was touted as one of the largest World's Fairs in history, attracting enormous crowds and an equally enormous number of criminals. To deal with the high volume of thieves, robbers, and assorted miscreants, Seattle Police request-

ed the assistance of the Pinkerton Detective Agency, which provided additional detectives and services to assist the SPD with this monumental task.

In addition to Seattle police officers and detectives, the AYP employed a guard force of approximately 20 officers to walk the grounds and maintain security. These guards were under the control of the SPD, were armed, and had limited police powers. Upon the conclusion of the AYP, many of the guard's applied to become Seattle Policemen. One of those who likely applied was the Sergeant of the AYP Guards, James Williston, who received this original letter of recommendation from Pinkerton Detective Supervisor W. H. Casey, who touted Williston's abilities as "capable, sober and efficient". Williston was an exemplary representative of the guard force, and his performance during the AYP would likely have offered him significant employment opportunities, as a result.





**Hobbies and Activities**




